State vacated all liens on the said properties after foreclosure, prior to gifting to Northfield Twp. Scott is going to conduct more research on Title Insurance. PFAS testing. Boat Stickers. Call forwarding to digital line. Contact DNR about floating Swimming Lines in Schrum. Per DNR direction, member swim sites/parks need ropes for delineation. Brian Trim motions to leave ropes/boundaries of HLC parks / swim areas as is, Scott Chisholm seconds. Motion passes.
- b. Electronic Gate Lock. Scott Chisholm sent information on electronic gate locks to board members via email. Total initial cost is \$1,046.80 for key fobs and software for two years. Total cost for five years is \$2,482.00. Supplier is a fairly new company on fifth generation of the lock. All members to keep their current keys, in case of electronic lock fail. \$15.00 per member every five years. Raising \$2,700.00 per five years. Cost is \$2,482.00. Brian Trim Motions to accept new boat launch key system, second by Julie Kapnick. Motion passes.

- c. Dues Foreclosure Updates.
  - a. Five Members (two are relatives) totaling around \$8,000 Skeens \$1830. VK \$1709. St Charles \$1007+\$2117. Redman \$1,546.70
  - b. Final letters telling them they WILL be foreclosed on in two weeks will go out tomorrow.

- G. Survey for George Browns Park (B-02-08-368-011). Proposed Bid is \$1100.00 for a partial survey. The partial survey will only mark the boundaries of property ID B-02-08-368-011, George Brown Park. The surveyor will keep the records in the event of a full survey is needed. The fee split is \$275.00 paid by HLC. \$550.00 paid by Justin Zlotucha, and \$275 paid by Tina Theeke. Tina Theeke and Justin Zlotucha requested the survey of parcel B-02-17-227-002, George Brown Park. Property ID, B-02-17-227-002 is 35x110, and is not lake lakefront. Tina Theeke is going to provide a 10-foot-wide easement through property ID B-02-08-368-011, to give access to Horseshoe Lake from the George Brown Park. Brian Trim Motions to approve the survey cost of George Brown Park. HLC cost will be \$275.00 for partial survey. Second by Ken Johnson. Motion passes.
- H. Phone and voicemail system. Brian Trim motions to change the voicemail line to a digital system. Julie Kapnick Seconds. Motion passes.
- I. 7987 Shady Beach Drive, Offensive Signs on property prohibited in HLC By-laws. Monthly fines are being assessed. The Northfield Township attorney states the signs are freedom of expression, and the Township cannot legally intervene. HLC, as a private organization, can intervene.
- J. Road Dues. Proposal to Raise all members road dues to \$100.00 per year. Scrum is the only sub which already pays \$100.00 per year. The rest of the subdivisions pay less per year. This proposal is presumed to be part of a membership vote this coming spring/summer.
